## RESOLUTION OF THE SKY RANCH METROPOLITAN DISTRICT NO. 1 TO AMEND THE 2024 BUDGET

Pursuant to Section 29-1-109, C.R.S., the Board of Sky Ranch Metropolitan District No. 1 (the "**District**"), hereby certifies that a regular meeting of the Board of Directors of the District, was held on November 10, 2023, at the offices of Pure Cycle Corporation, 34501 E. Quincy Avenue, Building 34, Watkins, Colorado 80137 and via video/teleconference.

A. At such meeting, the Board of Directors of the District adopted that certain Resolution No. 2023-11-02 to Adopt Budget appropriating funds for the fiscal year 2024 as follows:

General Fund\$252,580Debt Service Fund\$1,247,939

B. The necessity has arisen for additional General Fund appropriations requiring the expenditure of funds in excess of those appropriated for the fiscal year 2024.

C. The source and amount of revenues for such expenditures, the purposes for which such revenues are being appropriated, and the fund(s) which shall make such supplemental expenditures are described on <u>**Exhibit** A</u>, attached hereto and incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Sky Ranch Metropolitan District No. 1 shall and hereby does amend the budget for the fiscal year 2024 as follows:

General Fund \$265,000

BE IT FURTHER RESOLVED, that such sum is hereby appropriated from unexpected revenues available to the District to the General Fund for the purpose stated.
