Understanding your metropolitan district taxes and fees

Sky Ranch Metropolitan Districts and Community Authority Board

Your Sky Ranch master-planned community is operated and maintained by a group of Metropolitan Districts and the Community Authority Board (referred to as the "Sky Ranch Districts"). Colorado is commonly referred to as a "growth pays its own way" state. Accordingly, each new community must pay for and construct the necessary public infrastructure including water, sewer, storm drainage, roads, traffic signals, street lighting, parks, open space, and other public improvements to accommodate the impact of each new development. For Sky Ranch, metropolitan districts have been organized, which are independent political subdivisions of the State established pursuant to the Colorado Revised Statutes and provide such public improvements.

Jurisdictions have overlapping Special Districts to fund services including:



Mill Levy Comparisons




The mill levy is the amount charged per \$1,000 of assessed value (which the assessed value is 7.15% of the approximate market value of your home), which is divided among many parties - as noted on the previous slide. Your Sky Ranch Districts are comparable to area communities and the taxes the Sky Ranch District receives represents a portion (about 1/3) of your total property tax bill. These amounts are used to build and maintain the infrastructure in your community such as streets, curbs, sidewalks, water pipes, the parks, etc. Your property taxes are truly is an investment in your community!

Operations & Maintenance Fees


